Dreamhousing.com is strongly committed to protecting the privacy of its customers. We have written this privacy policy to inform you of the specific information that we collect from you, how we use this information, and what options you have in sharing this information with us when you visit our site either to promote your properties or to find the property of your choice. Protecting your privacy is of utmost concern and we are committed in providing you with a high quality service.

Information Collection and Use

Dreamhousing.com is the sole owner of the information collected on this site. We will not sell, share, or rent this information to others in ways different from what is disclosed in this statement. Dreamhousing.com collects information from our users at several different points on our website.

Listings

We request information from the user at registry. We also collect user information when the user makes a request of any of the listed properties in our site regarding additional information or when the user needs to contact the person or company listing the property. Here, a user must provide contact information (like name and e-mail) for the agent/broker, developer, sales person or homeowner to be able to contact them and advise them in the rental or sale of the specific property of their interest. Dreamhousing.com will also collect information such as (credit card number, expiration date). This information is used for the sole purpose of the billing process to upload any property to our site. If you have trouble processing and uploading your property please contact us. This contact information is used to get in touch with the user.

Dreamhousing.com has taken
important measures to protect your personal information. We store no financial

information on our site. Although you may have to enter your credit card number we use only secure servers using current Verisign encryption technology to encode your data safely.

The personal data we do store on our system is protected by firewall and password. Our network firewall is a combination of hardware and software designed to keep unauthorized users from accessing our network. The password you select, along with your unique email address, prevents others from accessing your information. We suggest that you do not disclose your password to anyone.

Third parties that have their own privacy policies that may be different than ours provide Third Party Service Providers - some of the services available through our website. You should review the privacy policy of third parties before providing your personal information to them.

Corrections/Updating Personal Information

At any time, dreamhousing.com can verify that the information you provided at the time of registration is accurate by checking on the status of your properties as well as your contact information. In the case that the posted information is false we reserve the right to remove it from dreamhousing.com. In the event that this incident arises we will send you an e-mail informing you of such a matter. Occasionally, we hire consultants that may need access to our member database to perform their services for us. We take great care to require that these business partners agree by contract not to use any member information that they may receive access to.

We will from time to time send you an e-mail regarding any changes that may apply to the status of your chosen plan. If you have any questions as well as changes or corrections you might have done to the information you have provided or if anything is incorrect please send us an e-mail. If you have to change or revise any of the information on any of your properties or personal data please log into your account and modify the information so it is always accurate and up to date. In the event that you cannot do it directly please call us or contact us via our customer service form as soon as possible.

To remove your personal information from our web site, email a request using the Contact Us form or unsubscribe directly with your username and password in the member services control panel.

Cookies

Dreamhousing.com uses a technology called "cookies," small files stored by your browser to help keep track of your user profile. Our cookies do not collect personally identifiable information, nor do we share them with anyone. We use cookies to remember your personal profile for your convenience, to deliver content specific to your needs and interests based upon your prior usage, and to ensure you don't see the same ad repeatedly. For instance, by setting a cookie on our site, the user would not have to log in a password more than once, thereby saving time while on our site. If a user rejects the cookie, they may still use our site but they will be limited to some areas within our site. We also use cookies to track user trends and improve areas of our sites that our users find valuable.

Links

This web site contains links to other sites. Please be aware that dreamhousing.com is not responsible for the privacy practices of such other sites. We encourage our users to be aware when they leave our site and to read the privacy statements of each and every web site that collects personally identifiable information. This privacy statement applies solely to information collected by dreamhousing.com.

Security

This website takes every precaution to protect our users' information. When users submit sensitive information via the website, your information is protected both online and off-line.

When our registration/order form asks users to enter sensitive information (such as credit card number and/or contact information), the information becomes encrypted and is protected by our third party service provider.

All of our users' information, not just the sensitive information mentioned above, is restricted in our offices. Only employees who need the information to perform a specific job (for example, a customer service representative) are granted access to personally identifiable information. Our employees must use password-protected screen-savers when they leave their desk. When they return, they must re-enter their password to re-gain access to your information. Furthermore, all
